**PROCEDURES & CHECKLIST**

**I. FILE PETITION**

- A. Petition to vacate street R.O.W., alley or easement signed by the property owners through whose property the easement extends. The petition shall state the names of the persons requesting the petition and state the legal description of the easement or portion of easement to be vacated. (Sample Petition on page 4.)
- B. A copy of the plat on record in the Circuit Clerk's Office which shows the street, alley and or easement to be vacated, together with the lot and block numbers of each lot which abuts upon the street or alley to be vacated.
- C. Abstractor's Certificate of Ownership stating names of all owners of property abutting the street R.O.W, alley, or easement to be vacated.
- D. Submit all the above at least 7 days prior to scheduled council meeting.

**II. NOTICE OF HEARING**

- A. At the next council meeting, the council shall by resolution (Sample Resolution on page 5) fix a day for the hearing of the petition and arrange for publication.
- B. Publication in some newspaper published in the county and having a general circulation in the city or town at least once a week for two (2) consecutive weeks prior to hearing date. There is a charge to publish the notice of hearing and petitioner will be billed for this charge, unless the petitioner incurs the cost directly.

**III. HEARING**

- A. Submit certificate of publication.
- B. Written consent of all owners of property abutting street R.O.W., alley, or easement to be vacated.
- C. Comments from all utility companies concerning the street R.O.W., alley or easement to be vacated and its relationship to existing or planned utilities with recommendations as to what action should be taken.

**PETITION TO VACATE AN ALLEY LOCATED IN  
BLOCK 1, DUNCAN’S ADDITION, CITY OF CENTERTON, ARKANSAS**

We, the undersigned, being all the owners of the real estate abutting the alley hereinafter sought to be abandoned and vacated, lying in Block 1, Duncan’s Addition to the city of Centerton, Arkansas, a municipal corporation, petition to vacate an alley which is described as follows:

(Legal Description)

That the abutting real estate affected by said abandonment of the alley are Lots 3 and 4 block 1 and Lots 5 and 6 Block 2, Duncan’s Addition to the City of Centerton, Arkansas, a certified copy of the original plat located in the Circuit Clerk’s Office for the County of Benton, State of Arkansas, is attached hereto, marked Exhibit A, and made a part hereof as though set out herein word for word.

Petitioners state that the above described real estate is not open and has not been used by the public for a period of many years, and that the public interest and welfare would not be adversely affected by the abandonment of the portion of the above described alley.

The petitioners pray that the City of Centerton, Arkansas, abandoned and vacate the above described real estate, subject, however, to the existing utility easements and sewer easements as required, and that the above described real estate be used for their respective benefit and purpose as now approved by law.

The petitioners further pray that the above described real estate be vested in the abutting property owners as provided by law.

WHEREFORE, the undersigned petitioners respectfully pray that the governing body of the City of Centerton, Arkansas, abandon and vacate the above described real estate, subject to said utility and sewer easements, and that title to said real estate sought to be abandoned be vested in the abutting property owners as provided by law, and as to that particular land the owner be free from the easements of the public for the use of said alley.

# Sample Ordinance

City of Centerton  
ORDINANCE NO. \_\_\_\_\_

AN ORDINANCE CLOSING THE PUBLIC RIGHT-OF-WAY or EASEMENT LOCATED AT \_\_\_\_\_; AND FOR OTHER PURPOSES;

WHEREAS, a petition was duly filed with the City Council of the City of Centerton, Arkansas on the \_\_\_\_\_ day of \_\_\_\_\_, 2018 asking the City Council to vacate and abandon (*all or part*) portion of the (*easement description*).

WHEREAS, after due notice as required by law, the council has, at the time and place mentioned in the notice, heard all persons desiring to be heard on the question and has ascertained that the easement or the portion thereof, hereinbefore described, has heretofore been dedicated to the public use as an easement herein described; has not been actually used by the public generally for a period of at least five (5) years subsequent to the filing of the plat; that all the owners of the property abutting upon the portion of the (*easement description*) to be vacated have filed with the council their written consent to the abandonment; and that public interest and welfare will not be adversely affected by the abandonment of the (*easement description*).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF CENTERTON, ARKANSAS;

**Section 1:** The City of Centerton, Arkansas releases, vacates, and abandons all its right, together with the rights of the public generally, in and to the (*easement description*) designated as follows:
